Introduction

County Cavan occupies an area of approximately 1,932km² and has a population of 76,176 (CSO 2016 Census). The County has boundaries with Counties Monaghan, Leitrim, Meath, Westmeath, Longford and Fermanagh.

The physical landscape of the County is characterised by its drumlin countryside dotted with lakes and hills. However, there are a number of landscape types all of which contribute to the uniqueness and distinctiveness of the County, from the Cuilcagh-Anierin Uplands Special Area of Conservation (SAC) and Corratirrim Limestone Pavements (SAC) in West Cavan to the Killyconny (Cloughbally) raised blanket bog (SAC) in South East Cavan. This range of landscape types have varying visual and amenity values, topography and contain a variety of biodiversity and ecosystems.

Unfortunately, issues associated with litter continues to be a national issue that requires a consistent and concentrated approach to address it effectively. This is no different in Cavan and litter continues to be a challenge locally.

The presence of litter devalues and degrades our local environment, it generates a negative impression of our County and detracts from the vision that Cavan will be a place that we all can be proud of; a place where people can enjoy a good quality of life; a better place to live, work and enjoy.

Litter is a highly visible form of environmental degradation that detracts from the natural beauty of our County. It is not only a blight on the landscape that devalues our towns, rural communities and natural resources, but also defaces our footpaths, roadsides, special areas of conservation, parks, waterways and threatens wildlife. Litter generates a negative impression on those who visit, live and work in the County, makes it less attractive for leisure, tourism and investment and places a significant fiscal burden on the Council's finances and resources.

Statutory Obligations

The Litter Pollution Act 1997 as amended was introduced on 1st July 1997 and provides the statutory framework for local authorities to prevent and control the litter problem in their functional area. The Act also introduced strong penalties which gives local authorities the power to take enforcement action against those who contravene these laws.

While litter seems a minor problem set against environmental crises such as global warming, climate change and biodiversity loss, it nonetheless has a negative impact on the appearance of our towns and countryside, on human health, on wildlife and represents a significant cost on local authorities to remove.

Before reviewing the actions taken under the Litter Management Plan 2016 – 2019 and identifying the main objectives of the Litter Management Plan 2021 – 2024, we first evaluate the following:

- What is the definition of litter?
- What are the prohibitions related to littering?
- What are the duties of local authorities, businesses and citizens in preventing littering?
- What are the enforcement measures available to local authorities?

Definition of Litter

The definition of litter is quite broad and extends beyond small waste items discarded inappropriately i.e. cigarette litter, food related litter including chewing gum, sweet papers, single use cups and bottles, etc. It also includes graffiti, unauthorised signage and any item which is likely to become unsightly.

Section 2(1) of the Litter Pollution Act 1997 as amended defines litter as “a substance or object, whether or not intended as a waste (other than waste within the meaning of the Waste Management Act 1996 as amended, which is properly consigned for disposal) that, when deposited in a place other than a litter receptacle or other place lawfully designated for the deposit, is or likely to become unsightly, deleterious, nauseous or unsanitary, whether by itself or with any other substance or object, and regardless of its size or volume or the extent of the deposit”.

Prohibitions relating to Litter

Section 3(1) of the Act states that “no person shall deposit any substance or object so as to create litter in a public place or in any place that is visible to any extent from a public place”.

Section 3(2) of the Act states that no person shall (a) deposit anything that is commercial, household, industrial or municipal waste in any place for collection by or on behalf of a local authority or by another person, or (b) load transport, unload or otherwise handle or process anything or carry on a businesses, trade or activity in such circumstance as to create litter or lead to litter in any public place or any place that is visible to any extent from a public place.

Section 3(3) of the Act states “no person shall place *municipal waste*¹ into or near a litter receptacle”.

Section 3(4) of the Act states “no person shall move or interfere with a litter receptacle that has been provided by a local authority or other person unless the movement or interference is authorised by the Council or other person”. A person who contravenes any of the above provisions shall be guilty of an offence.

Duty of occupiers regarding litter

Section 6(1) of the Act states that “the occupier of a public place (not being a public road or a building or other structure) shall keep the place free of litter”.

Section 6(2) of the Act states that “the occupiers of any land (other than land consist of a building or other structure) that is not a public place shall keep the land free of litter that is to any extent visible from a public place”.

Local Authority Functions and Duties Generally

Duty respecting public roads

Section 7 of the Act states “a local authority shall ensure that each public road in its functional area is so far as practicable kept free of litter”.

Prevention of creation of litter

Section 8(1) of the Act states that a “a local authority shall take all practicable measures for the prevention of the creation, and for the prevention and overcoming of the polluting effects, of litter in its functional area and for the control and disposal of litter and, for those purposes, may enter into arrangements with, or assist, other persons (including other local authorities) for or in the taking of such measures on behalf of the authority.”

¹ means household waste as well as commercial and other waste which, because of its nature or composition, is similar to household waste

Measures taken shall include:

- (a) The collection and disposal of litter
- (b) Promote awareness of the polluting effects of litter
- (c) Encourage participation by persons in preventing and overcoming litter
- (d) Provision of facilities and services in relation to litter, including publicity, advisory and educational services

Littering Related Matters

Mobile Outlets

Section 15(1) of the Act states that “the owner, occupier of person in charge of a mobile outlet that is used wholly or partly for the sale of produce, food or drink shall, at all times when the outlet is open to customers provide and maintain adequate litter receptacles in order to prevent the creation of litter at or in the vicinity of the outlet while it is in operation”. Any litter caused by the operation of the outlet must be removed from the vicinity within a radius of 100 metres from their outlet.

Major Events

Under Section 17 of the Act, promoters or organisers of major events are required to ensure that they have litter control measures in place at the venue and in the surrounding vicinity before, during and after the event. This applies to any event including sporting events where a large number of persons are likely to be present.

Advertising Posters and Signs

Under Section 19(1) of the Act it is prohibited to exhibit any advertisement (posters and signs) on land, including grass verges and roadsides, poles, or other structures which are located in or visible from a public place without permission from the local authority. Some exemptions may apply for local events under Planning and Development Regulations 2011 as amended.

Advertising Flyers

Under Section 19(2) of the Act, the placing of advertising material on a mechanically propelled vehicle in a public place is prohibited.

Dog Related Offences

Under Section 22 of the Act, where faeces have been deposited by a dog in any place outlined below and the person in charge of the dog has not **immediately** removed the faeces and ensured its appropriate disposal, that person shall be guilty of an offence. This applies to the following locations:

- Public roads and footpaths.
- Land forming part of a retail shopping centre.
- Schools, sports grounds, playing fields or recreational area.
- The curtilage of another person’s property.

Enforcement

Litter & Waste Complaints

The Council acknowledges the support that it receives from the public in the reporting of incidences of littering. These complaints can be reported directly to the Council by telephone, via email, the Environmental Complaint Form on the Council's webpage and through the Council's social media. Complaints can also be made through the National Environmental Complaints Line on 1850 365 121 or through the "See It?, Say It?" app. All complaints received are recorded and fully investigated.

On-the-Spot Litter Fines

The Council has the power to proceed with enforcement action for litter offences under the Litter Pollution Act 1997 as amended. Leaving or throwing litter in a public place is an offence which can be subject to an On-the-Spot Litter Fine of €150 and a maximum fine of €4,000 via successful prosecution through the courts. Any person convicted of a litter offence may be required by the Court to pay the Council's costs and expenses in investigating the offence, site clean-up and in bringing the prosecution to Court.

County of Cavan (Segregation, Storage and Presentation of Household and Commercial Waste) Bye-Laws, 2019

Pursuant to Part 19 of the Local Government Act 2001, as amended and Section 35(1) of the Waste Management Act 1996, as amended, the Council have made Bye-Laws in relation to the segregation, storage and presentation of household & commercial waste within its functional area. These Bye-Laws have been made in the interests of the common good, to ensure the proper management of waste and to assist in the prevention and control of environmental pollution. These Bye-Laws came into force on the 13th December 2019.

Scope of the Litter Management Plan 2021 – 2024

Section 10 of the Litter Pollution Act 1997 as amended requires local authorities to make and implement a Litter Management Plan in respect of its functional area. Local authorities shall review its Litter Management Plan at least once in each 3 years after the plan is first implemented.

A Litter Management Plan shall:

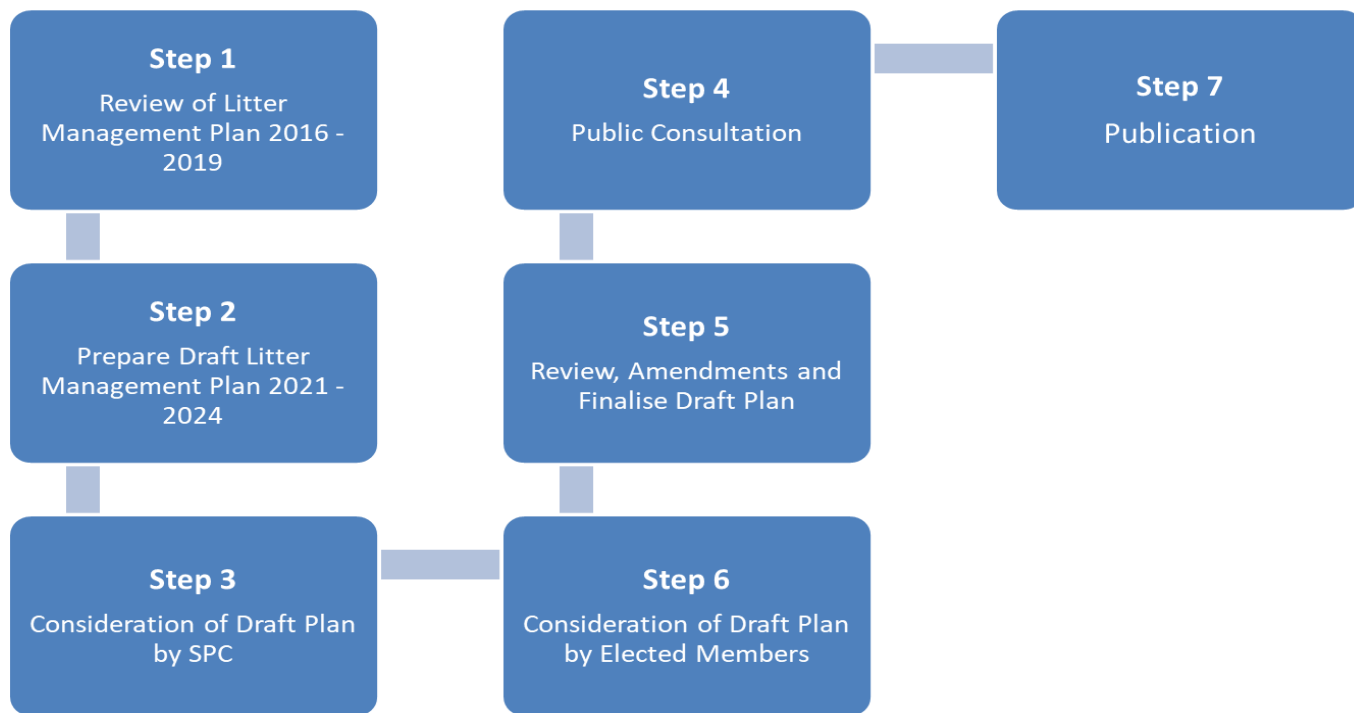
- (a) specify such objectives as the local authority deems are appropriate to prevent and control litter in its functional area,
- (b) specify the measures to encourage public awareness with a view to eliminating litter pollution, including educational and information measures directed at young persons,
- (c) specify the measures or arrangements that are to be undertaken by the local authority in order to attain the objectives of the plan, and
- (d) include information on, or be formulated having regard to:
 - (i) an appraisal of all existing litter prevention and control programmes being operated by the local authority.
 - (ii) the policies and objectives of the local authority in relation to the prevention and control of litter.
 - (iii) the measures which, in so far as the local authority can determine, will or may be taken during the relevant period by persons other than the local authority for the purposes of preventing and controlling litter.
 - (iv) the facilities at which waste may be deposited by members of the public for recovery or disposal within the meaning of the Waste Management Act, 1996 as amended.
 - (v) the steps to be taken by the local authority to enforce the provisions of this Act in its functional area.
 - (vi) any incidental and ancillary matters.

This Litter Management Plan evaluates the litter prevention and control measures taken by the Council and other agencies during the period 2016 – 2019. It also outlines objectives for the period 2021 – 2024 and includes information on:

- Educational and operational strategies to raise public awareness of the litter problem.
- Enforcement and prevention measures undertaken under the Litter Pollution Act 1997 as amended.
- Litter prevention and control activities undertaken by the Council and other agencies.
- Recycling and recovery facilities provided for public use.
- Information on the Council's Waste Presentation Bye-Laws.

Our goal is to protect and enhance Cavan’s natural beauty through education, awareness and preventative initiatives, enforcement measures and continuing to work in partnership with our Tidy Town Network, Green Schools Programme, community and voluntary groups, businesses and citizens.

Procedure for making, amending or replacing a Litter Management Plan



Step 1 – Review of Litter Management Plan 2016 – 2019

- Consultation was held with Waste Management and Enforcement staff to review the previous Litter Management Plan 2016 – 2019, evaluate performance against the targets outlined in the Plan and identify objectives for the new Draft Plan.

Step 2 – Prepare Draft Litter Management Plan 2021 – 2024

- A review of internal consultation was undertaken and the Draft Litter Management Plan was prepared by the Litter Management Officer.
- The new Draft Plan was presented to the Waste Management and Enforcement staff for consideration.

Step 3 – Consideration of Draft Plan by SPC

- The Draft Plan must be approved by the Climate and Biodiversity Action and Environment Strategic Policy Committee for the statutory public consultation phase to commence. The objectives of Draft Plan was presented to the SPC on the 14th December 2020 for consideration with no amendments required.

Step 4 – Public Consultation

- The prolonged restrictions on the opening of public buildings imposed by the COVID-19 pandemic delayed the initiation of this step. The public consultation phase commenced on Friday, 2nd July 2021.
- Notice of publication was placed in the Anglo Celt commencing on Thursday, 1st July 2021 and was published each week until Thursday, 29th July 2021.
- The Draft Plan was also advertised through the Council’s social media outlets.
- During the public consultation phase, the Draft Plan was on display in the Johnston Central Library, Farnham Street, Cavan during its normal opening hours.
- The Draft Plan was also available to view and download from the Council’s website www.cavancoco.ie.
- The Draft Plan was circulated to all 18 No. Elected Members and to 320 No. voluntary groups via Cavan PPN including 25 No. Tidy Towns groups.
- Submissions and observations were invited from members of the public and from voluntary and representative bodies. They were requested to submit their observations in writing to Jim Lyng, Environmental Awareness Officer, Waste Management Section, Old Library Building, Farnham Street, Cavan or by email to litterplan@cavancoco.ie.
- **The closing date for the receipt of submissions was 5.00pm on Friday, 30th July 2021.**

No submissions were received.

Step 5 – Review, Amendments and Finalise Draft Plan

- A final review of the Draft Plan was completed. As no submissions were received, no further amendments were made to the Draft Plan and the final draft was prepared for consideration by the Elected Members.

Step 6 – Consideration of Draft Plan by Elected Members

- The final Draft Plan was presented to the Elected Members of Cavan County Council at the November 2021 Council meeting held on 8th November in the Hotel Kilmore. The Draft Plan was discussed in great detail and received unanimous support from the Elected Members and was formally adopted by the Council at this meeting.

Step 7 – Publication

- The final phase is the publication of the full and final Litter Management Plan 2021 – 2024. The Plan is available to download from the Council’s website www.cavancoco.ie and will be circulated to all libraries and public buildings throughout the County.

Review of the Litter Management Plan 2016 – 2019

Introduction

The previous Litter Management Plan was published by the Council in 2016. The Litter Management Plan 2016 – 2019 described the activities and resources to be put in place by the Council for the management of litter over this period. A summary report on measures taken over the period 2016 – 2019 is presented below:

Expenditure on Litter Prevention and Control

During the lifetime of the Litter Management Plan, the Council expended significant resources and effort on its street cleaning, litter prevention and control activities and public awareness activities. Expenditure by the Council during the period 2016 – 2020 is set out hereunder:

Objective 1: Education and Awareness

Education Measures

Green Schools Programme

Cavan has a well-established Green Schools Programme (GSP). The GSP is operated and co-ordinated by the Environmental Education Unit of An Taisce and co-ordinated locally by the Council. The GSP promotes long-term, whole-school action for the environment. It is a student-led programme with involvement from the wider community.

There are over 90 educational institutions (primary schools, post primary schools, special schools, a third level institution and adult education centres) in the County with approximately 90% (87 educational institutions) having registered and participated in the programme since its inception in 1997.

There are now 10 Green Flag themes which include Litter & Waste, Energy, Water, Travel, Biodiversity, Global Citizenship Litter & Waste, Global Citizenship Energy, Global Citizenship Marine Environment, Global Citizenship Travel and Global Citizenship Food & Biodiversity. Litter and Waste is the first theme of the GSP and is a recurring theme throughout all flag renewals. The number of Green School Flags awarded in County Cavan are detailed below:

Tidy Schools Competition

The inaugural Tidy Schools Competition took place during the Summer of 2019. The competition was based on 5 criteria – Participation in the Green Schools Programme, Litter and Waste Prevention, Recycling and Anti-Litter Promotion, Biodiversity and Links to the Community. Marks were awarded to each school under each of the above headings.

The overall winners were Scoil Bhríde in Killeshandra.

Gum Litter Taskforce (GLT) Awareness Campaign

Chewing gum is one of the largest components of litter in the County. The GLT have a specific education programme for primary schools which aims to inform young people about the environmental damage and social cost of littering when items such as chewing gum are disposed of carelessly.

The Council fully participated in this awareness campaign over the last 3 years and launched our campaigns in Kingscourt in 2017, Cootehill in 2018 and Cavan Town in 2019.

Waste Management Guidelines Information Booklet

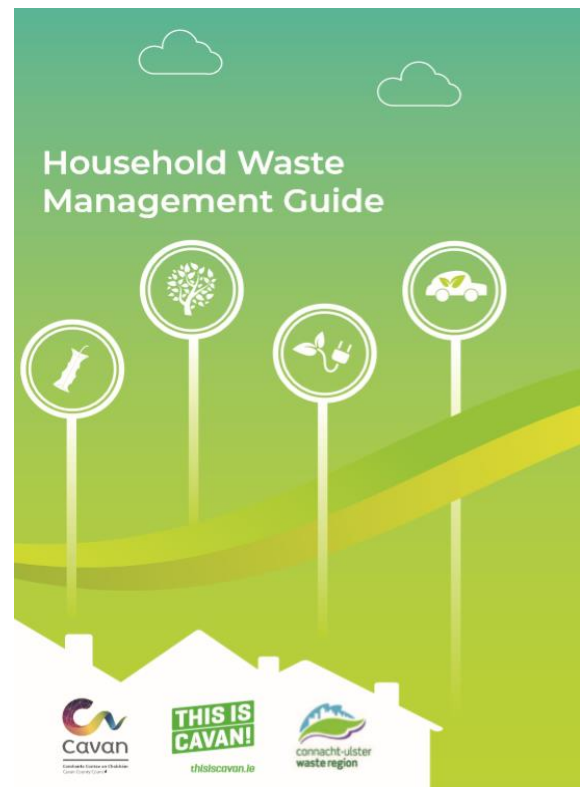
Funded by the Department of Communications, Climate Action and Environment and as part of the Anti-Dumping Initiative 2019, the Waste Management Section designed an information booklet “Household Waste Management Guide”.

This 20-page booklet provides advice on how to appropriately manage household waste and includes measures on how to prevent and reduce waste at home.

This booklet was distributed to the readers of the Anglo Celt as part of Celtic Media Groups “Green Future” production which was published in October 2020.

The booklet will be also be distributed to householders at workshops, trade shows and information days held/attended by the Council in the future.

It will also be distributed to new Council Housing Tenants upon completion of their Pre-Tenancy Training and through the Green Schools Programme and Tidy Towns Network.



Awareness Measures

National Spring Clean

The National Spring Clean Campaign which runs throughout Ireland during the month of April has gone from strength to strength in County Cavan over the past 3 years. In support of this campaign, we encouraged Green Schools, Tidy Towns Groups, local community and voluntary groups, resident associations and businesses throughout the County to become involved in clean-up projects in their area.

Bags, gloves, litter pickers and high-vis vests were among the items provided to groups to assist in their clean ups. Groups from all over the County participated in the campaign and large amounts of roadside litter were collected each year. The number of groups participating in this campaign have steadily increased since 2016.

Dog Fouling

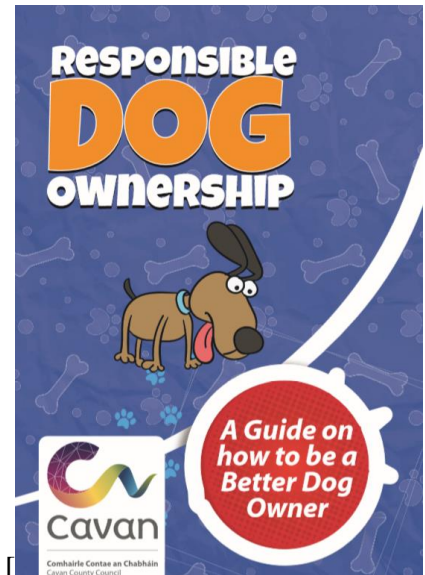
Dog Fouling is another form of litter and the Council has run awareness campaigns to inform the public that under Section 22 of the Litter Pollution Act 1997 as amended, that it is an offence for a person in charge of a dog not to clean up **immediately** after their dog fouls in a public place.

The Council have published a “Responsible Dog Ownership” information booklet which was distributed at workshops, information days and trade shows hosted/attended by the Council and through our Green Schools Programme.

The Council have also provided Tidy Towns Groups with stencils which can be used on footpaths and along walking routes that grab the attention of the public on issues relating to Dog Fouling.

The Community Wardens and Dog Warden undertook regular litter patrols of areas where high levels of complaints of dog fouling were reported.

In 2018, the Council ran its “Save our Soles” billboard campaign which was displayed on the N3, Cavan to Dublin Road at New Inns with an average daily flow of traffic of 12,229 vehicles (Transport Infrastructure Ireland).



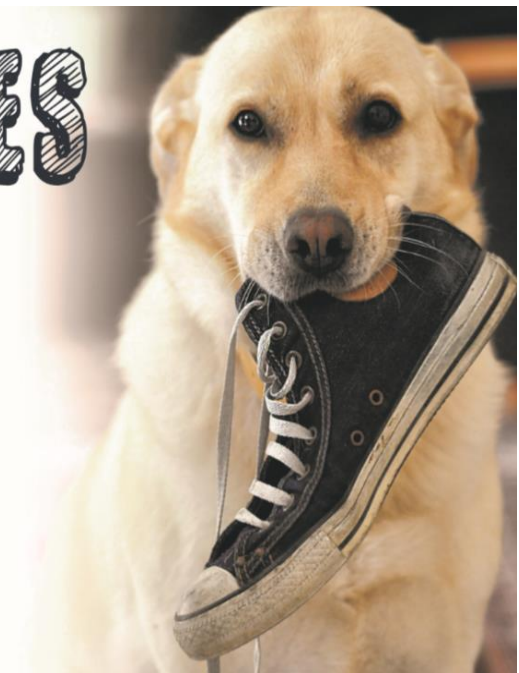

County Litter Leagues

The Council worked with local communities to improve the cleanliness and appearance of our towns, villages and countryside. The Council used similar inspections and scoring criteria employed by IBAL for Cavan Town. The County Litter League was based on regular inspections of 28 towns and villages within the County. All selected towns and villages were surveyed by litter enforcement staff. For results of the 2016 – 2019 Litter Leagues, please refer to Appendix 3.

National Litter Pollution Monitoring System (NLPMS)

NLPMS is a system for monitoring the extent and severity and causes of litter pollution. Tobin Consulting Engineers, on behalf of the Department of Communications, Climate Action and Environment administer the system. Local authorities feed data into the system annually following regular surveys. The data produced by NLPMS surveys allow local authorities to gauge the extent and severity of litter pollution in their administrative area, the types, most likely sources and causes of litter pollution, the changes in litter levels from location to location and the location of litter blackspots.

Under the national monitoring system, the **extent** and **severity** of litter pollution is measured using a Litter Pollution Index (LPI), which is a scale of 1 to 5 as described below:

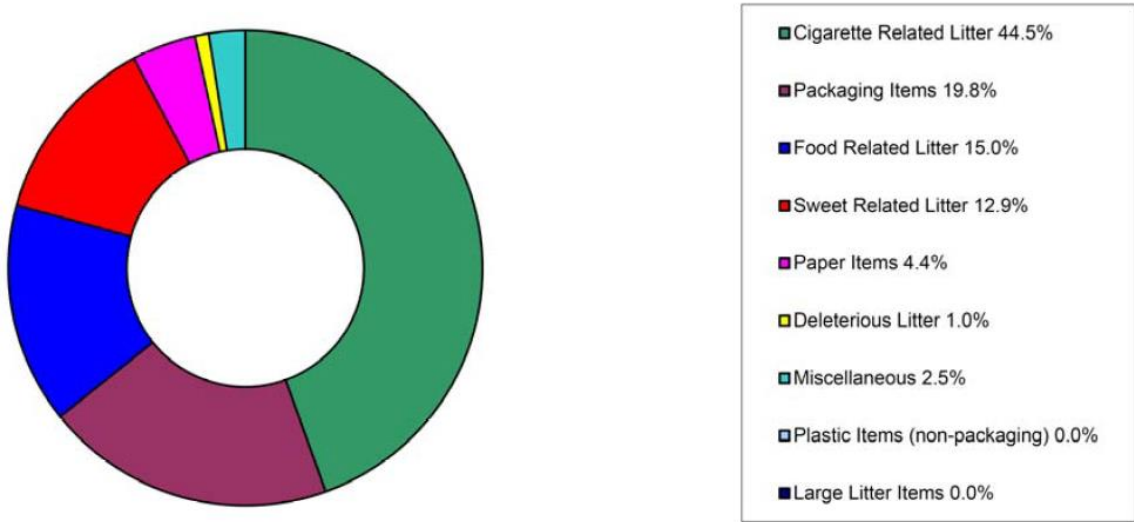
1. Unpolluted or Litter Free
2. Slightly Polluted
3. Moderately Polluted
4. Significantly Polluted
5. Grossly Polluted

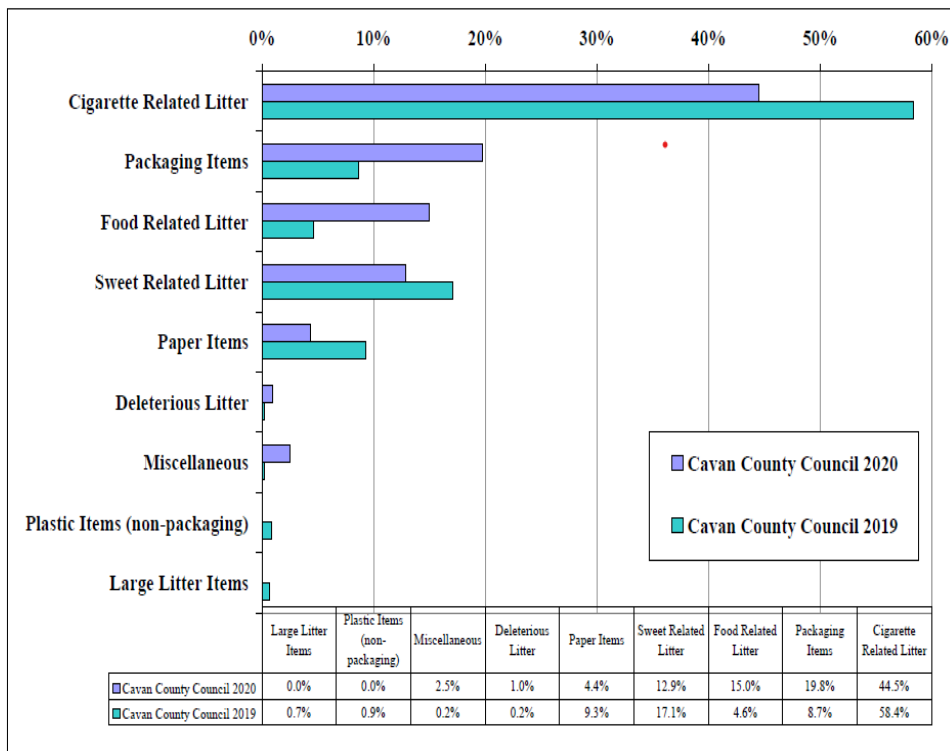

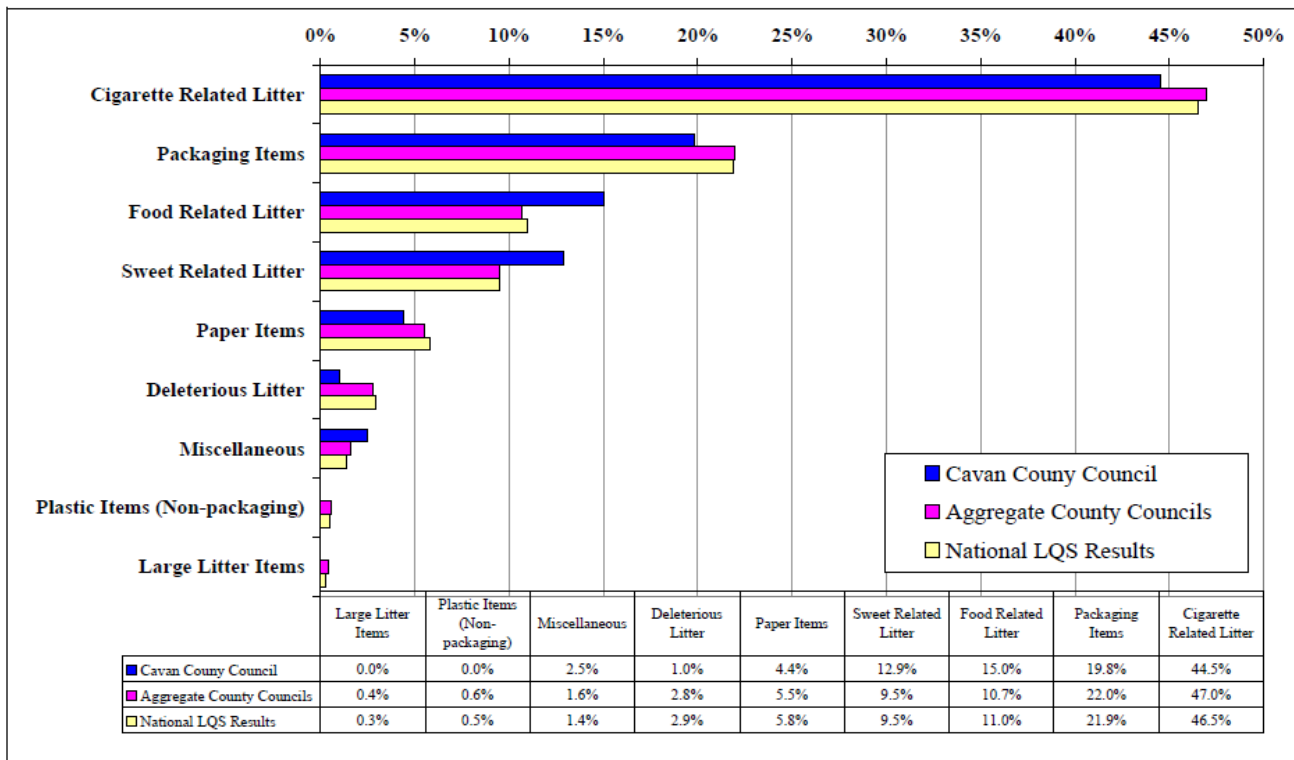
Litter Composition in Cavan County Council, 2020

Comparison of Litter Composition in Cavan County, 2019 and 2020

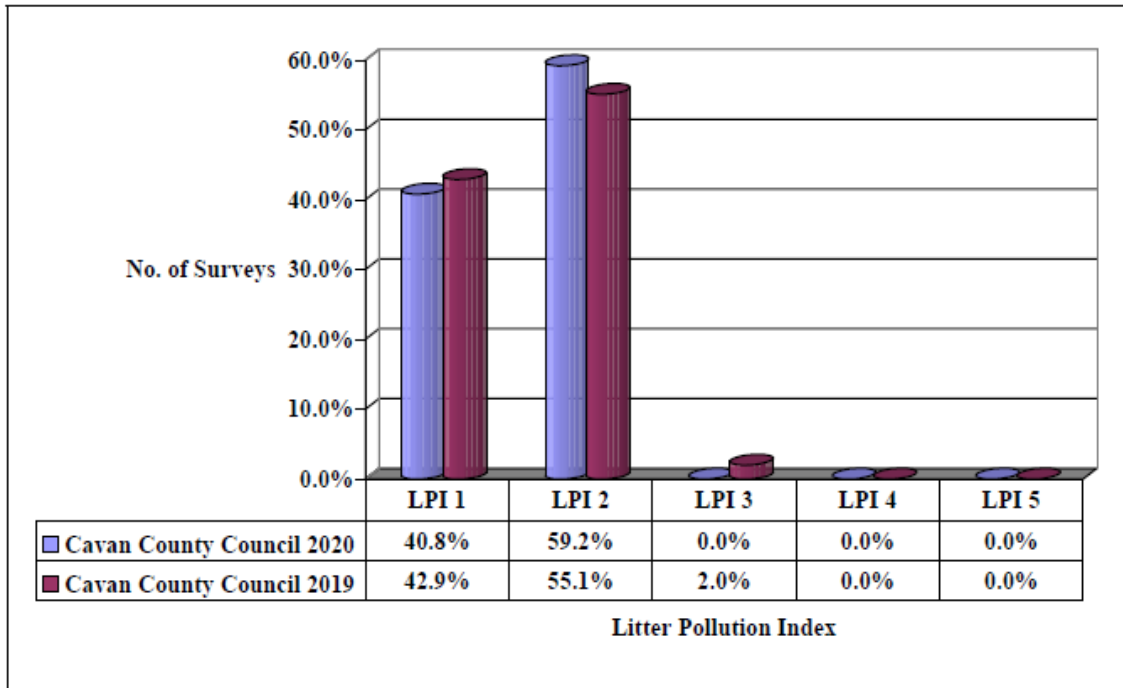

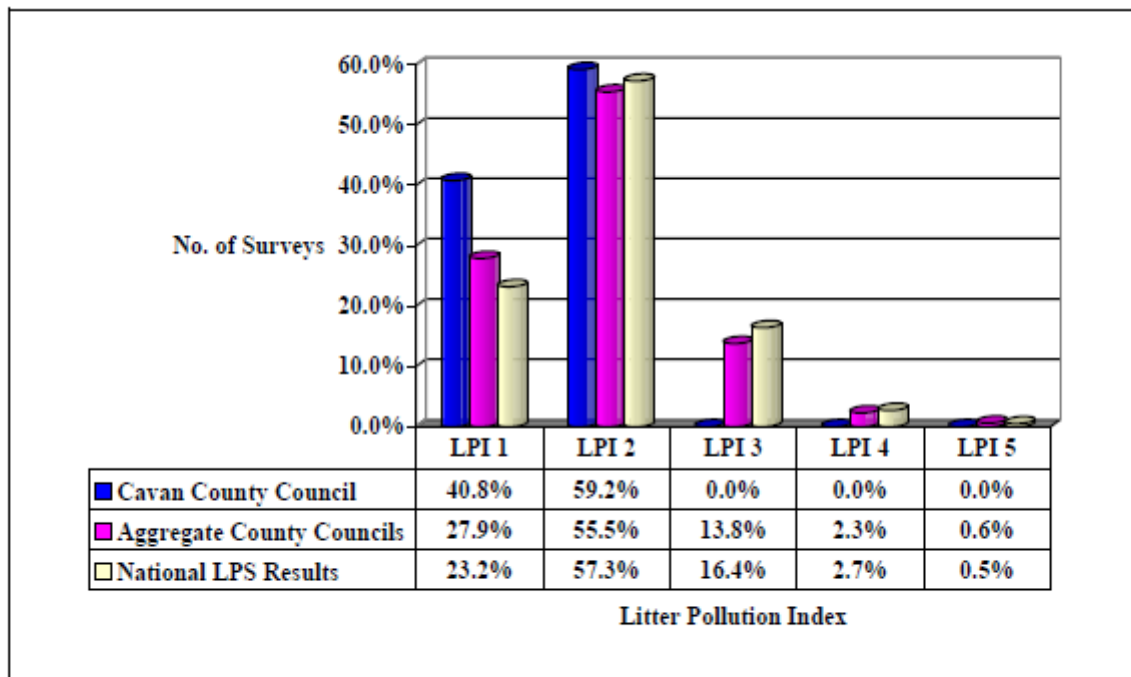

“It’s Not in Our Nature” Anti-Dumping Media Campaign

The Council have participated in the ‘It’s Not in Our Nature – is it in Yours?’ Anti-Dumping media campaigns since 2017 along with all other local authorities in the Connacht Ulster region to highlight issues around illegal dumping. This project has been run by the local authorities with the support from the Connacht Ulster Waste Region Enforcement and Planning Offices, the Department of Communications, Climate Action and Environment (DCCA) and stakeholders across the region.

A wide range other projects haven taken place across the County including abatement measures, preventative measures and education and awareness measures which are explained in greater detail throughout this document.



European Recycling Platform (ERP)

The Council have supported awareness campaigns run by the ERP including “Don’t Waste a Day” and “Batteries for Barretstown” to remind consumers that any appliance with a plug or battery can be recycled for free and if these electrical and electronic devices are not disposed of in a sustainable way, the hazardous materials contained within them can damage both the environment and human health through leakage.

Stop Food Waste Challenge

In September 2017, the Council ran its first Stop Food Waste Challenge in Cavan Town and Bailieborough. This 4-week challenge was attended by staff members of the Waste Management Section, members from the local Tidy Towns Groups and members of the public.

How it worked

- Consisted of 4 x 1-hour meetings over 4 consecutive weeks.
- Workshops were led by a trained facilitator.
- Each meeting had a structured approach and consisted of a few elements – a video presentation, presentation from trained facilitator, group discussion, and challenges set for the following week.
- All participants were set a target to reduce their household waste by 25%.



The aim of the 4-week challenge was to raise awareness to the amount of food waste we as householders throw out. It also offered advice on simple ways householders can change their habits to reduce the amount of food waste that ends up in their bin each day and reducing the amount of money spent on food that is bought but never eaten.

This training programme continued in 2018, with the 4-week challenge held in Belturbet and Virginia. In total 47 participants took part between the four locations.

In 2019, as part of the Virginia Agricultural Show, the Council facilitated a Stop Food Waste Forum attended by staff from Clean Technology Centre, Cork.

Social Media Campaigns and Information Booklets

The Council have designed and published numerous information booklets and leaflets providing information on the following issues:

- Food waste prevention and recycling.
- Waste Prevention & Recycling Tips & Tricks information booklet.
- Your Community Your Environment in partnership with Irish Peatland Conservation Council.
- Responsible Dog Ownership booklet.
- Household Waste Management Guide.
- Recycling Bring Centres
- Information leaflets on Energy Conservation, Food Waste Prevention, Home Composting, Household Hazardous Waste, Waste Prevention in the Home and Water Conservation in the Home as part of European Week for Waste Reduction.

Water Conservation and Eliminating use of Single Use Plastics

A number of waste prevention and awareness projects were undertaken by the Waste Management Section in collaboration with Refill Ireland. The objectives of the project were to increase awareness regarding water conservation and to reduce consumption of single use plastics

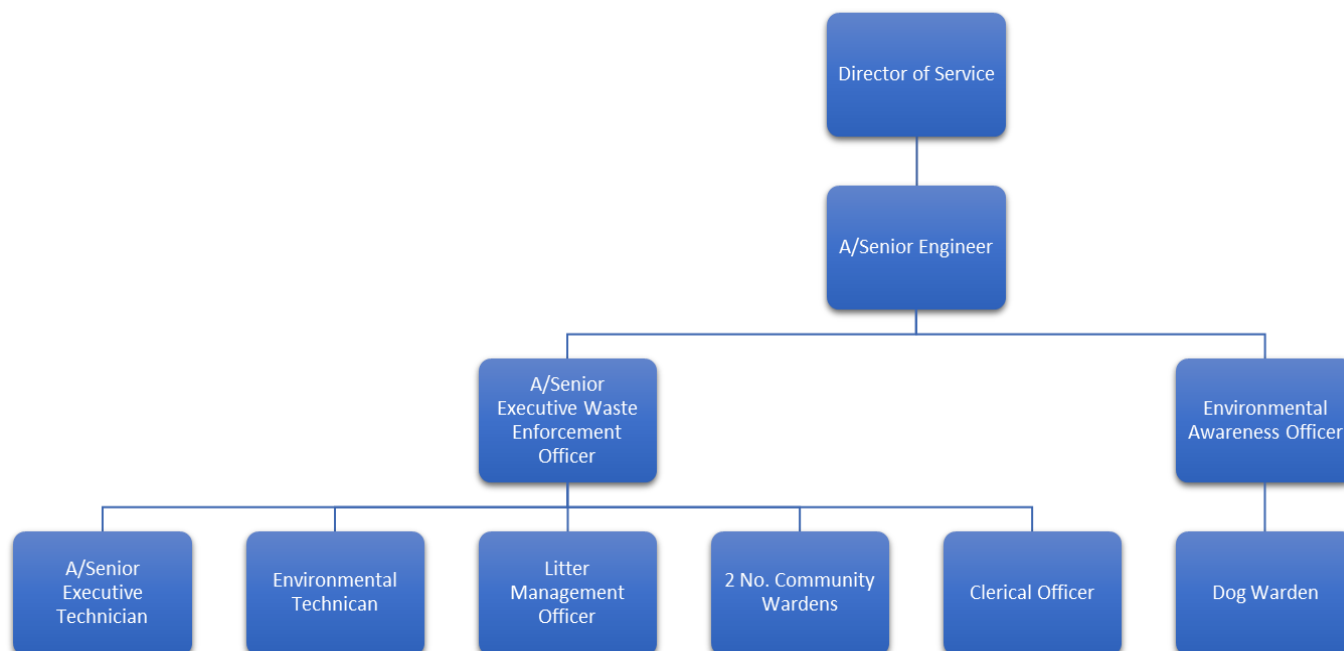
The Waste Management Section provided an education stand at Cavan's 2-day food festival "Taste of Cavan" in August 2019 with Refill Ireland also in attendance and ran social media campaigns promoting waste minimisation and seeking to build a network of businesses across the County to provide free water refills to people who use reusable water bottles/cups.



Objective 2 - Enforcement and Prevention

Enforcement Measures

The Waste Enforcement Staff Structure is outlined below:



The Community Wardens and Dog Warden are the visible face of the Council's various litter prevention strategies and represent a considerable opportunity to increase public awareness of the litter problem and enforcing the parameters of the Litter Pollution Act 1997 as amended. The Community Wardens' activities have included:

- Assisting Tidy Towns Groups, community and voluntary groups and resident associations in their activities.
- Undertaking Litter Patrols which enables the Community Wardens to take immediate action in relation to new litter blackspots, fresh incidents of illegal dumping, abandoned vehicles, etc.
- Visits to retail, industrial and commercial premises in the County to advise owners of their responsibilities under the Litter Pollution Act 1997 as amended.

The LMO is also the Green Schools Co-ordinator for the Council and visited schools to raise awareness on anti-litter initiatives and education on waste management and prevention practices. The LMO assisted the Tidy Towns Network by coordinating Anti-Litter and Anti-Dumping Initiatives such as National Spring Clean and Anti-Litter and Anti-Graffiti Grants and assisted the EAO in creating awareness campaigns.

Litter & Waste Complaints

All litter and waste complaints reported to the Council are recorded and fully investigated. We endeavour to deal with these complaints in a prompt, efficient and effective manner. Below is a breakdown of the number of complaints investigated during the period 2016 – 2020:

As part of its daily operations, the Enforcement Team also carried out routine litter patrols and household and commercial waste management inspections. This work will continue in tandem with the newly passed Waste Presentation Bye-Laws.

CCTV and Improved Technology

The placement of permanent and temporary CCTV equipment at locations such as the Council's Recycling Bring Centre Network and litter/dumping blackspots took place to deter the misuse of recycling facilities and deter littering and dumping at remote rural locations. A mixture of covert and overt CCTV equipment was deployed.

As part of the Anti-Dumping Initiatives in 2017 and 2018, the Council invested in new technology including handheld tablets used by the Enforcement Team to document investigations and patrols and a drone which is used by the Enforcement Team to detect, deter and investigate incidents of littering and illegal waste activity.

The drone provides the Enforcement Team on the ground with enhanced visibility in difficult-to-reach remote and rural areas. Areas where illegal dumping has been highlighted as an issue as well as historic landfill sites can be monitored, and the drone will assist staff in collecting more detailed data and improving daily operational efficiency.

County of Cavan (Segregation, Storage and Presentation of Household and Commercial Waste) Bye-Laws, 2019

The Council has made Bye-Laws in relation to the segregation, storage and presentation of household & commercial waste within its functional area. These Bye-Laws have been made in the interests of the common good, to ensure the proper management of waste and to assist in the prevention and control of environmental pollution. These Bye-Laws came into force on the 13th December 2019.

These Bye-Laws will apply to all households, apartments and commercial premises. In order to manage your waste correctly you need to be able to prove that:

- You have a contract in place with an authorised waste collector (bin sharing is permitted for which proof of agreement is required)

OR

- You can demonstrate regular use of an authorised waste facility (Civic Amenity Centre)

Abandoned Vehicles/End of Life Vehicles

Vehicles are often abandoned on roadsides, and on public open spaces including residential areas.

It is an offence under Section 71 of the Waste Management Act 1996 as amended to abandon a vehicle on any land and both the person who placed the vehicle at the place where it was abandoned and the registered owner are liable to be prosecuted with fines of up to €5,000 and/or 12 months in prison.

The Council may enter on any land upon which a vehicle has been abandoned and remove the said vehicle. Where a vehicle is removed from land by the Council, the Council will endeavour to contact the registered owner by way of written notice as soon as it is possible thereafter. 57 No. Section 71 Notices were issued during the period 2016 – 2020.

Abandoned vehicles may be claimed by the registered owner under certain circumstances and conditions but shall be subject to payment of recovery and storage costs incurred by the Council before the vehicle can be returned.

Prevention Measures

Street Cleaning Operations

The three Municipal Districts (Cavan Belturbet MD, Cootehill Bailieborough MD and the Ballyjamesduff MD) provided street cleaning and associated services across their administrative districts. The street cleaning service was a combination of mechanised cleaning with manual sweeping as necessary on a set schedule set out by the relevant Municipal District. The associated services included emptying of public bins, maintenance of street furniture, weed control (from April to September inclusive), gulley cleaning and leaf removal during winter months.

Litter Patrols

The Community Wardens carried out daily patrols in respect of litter enforcement. Many of these patrols took place in towns, housing estates and areas prone to littering/dumping.

Bank ATM Surveys – Negotiated Agreement with the Banking Sector

Litter surveys are conducted by local authorities on an annual basis and the results are collated and analysed by the Department of Communications, Climate Action & Environment. This information is used to gain an informed position as to how the Banking Payments Federation Ireland (BPFI) members have been implementing Measure 3 of the agreed protocol.

The Litter Management Officer conducted a minimum of 20 No. litter surveys each year for the period 2016 – 2019 with respect to the cleanliness of the street areas adjacent to and in front of commercial banks in the County's main towns.

Dog Fouling

Since November 2017, the Waste Management Section has distributed dog fouling bag dispensers to Tidy Towns Groups for installation at key amenity areas including parks and popular walking routes.

To date, the Council has provided over 80 dog fouling bag dispensers (and a continuous supply of bags), along with pole mounted signage and footpath stencils.



Water Conservation and Eliminating use of Single Use Plastics

A number of waste prevention projects were undertaken by the Waste Management Section in collaboration with Refill Ireland, Tidy Towns Groups and the Green Schools Programme across County Cavan. The objectives of the projects were to increase awareness as regards water conservation and to reduce consumption of single use plastics.



Greening a sporting event:

The Waste Management Section coordinated with Healthy Cavan and Refill Ireland to attend a 5KM run at Killykeen in October 2019 as part of Reuse Month. Refill Ireland supplied a hydration station and reusable beakers and eliminated the need for single use plastic bottles.



Green Schools:

As part of the Green Schools Programme to promote responsible consumption, the Waste Management Section focused on waste prevention initiatives and specifically on the elimination of single use plastics. The Council provided all participating schools with reusable sports bottles made from sugar cane and started the roll out of installing water refill stations to post primary schools. In 2019, the Waste Management Section funded by the Local Authority Prevention Network provided 2 No. Water Refill Stations at Breifne College, Cavan catering for 750 students and 80 staff. In 2020, the Council provided water refill stations to St. Aidan's Comprehensive, Cootehill and Colaiste Dun an Ri, Kingscourt.

Reusable Cup Initiative

The aim of the Reusable Cup Initiative was to reduce single use cups in the County. The initiative was launched in November 2017 by the Cathaoirleach of Cavan County Council and Bailieborough Tidy Towns. The central focus of the campaign was to work with Tidy Towns Groups to encourage citizens to switch to reusable cups and prevent litter and waste caused by single use cups.

Anti-Dumping Initiative

In March 2017 Mr. Denis Naughten, Minister for Communications, Climate Action & Environment launched the above initiative to address illegal dumping across the country. The aim of the initiative was to tackle illegal dumping and provide local authorities with support to monitor and ensure the surveillance of dumping blackspots and develop an integrated approach to deal with this issue.

The Council have participated in this initiative each year since its inception and have undertaken projects under the following categories:

- Abatement Measures
- Prevention Measures
- Education Measures
- Enforcement Measures

Abatement Measures

These works involved the clean-up, removal and disposal of historical waste dumped at known dumping blackspots. Abatement measures undertaken since 2017 are detailed below:

Prevention Measures - Bulky Waste Collection Days

The Council in partnership with other stakeholders undertook a wide range of Waste Collection Days.

As part of Anti-Dumping Initiatives funded by DCCAE, the Council have held a number of Bulky Waste Collection days at the Corranure Civic Amenity Centre where items such as mattresses, couches, 3-piece suites and household furniture were accepted.

Other items collected in August 2020 included: timber furniture i.e. chipboard, bedside lockers, wardrobes, chest of drawers, timber flooring, laminated flooring, timber fencing, shelving, dining tables and chairs, internal doors, carpet, underlay and lino, bed base’s, headboards, duvets and pillows, fireplaces, office furniture i.e. office chairs, desks, filing cabinets, car seats, prams, cots and strollers. 30 tonnes of waste was collected on the day.

Education Measures

In 2019, the Waste Management Section created a 20-page Household Waste Management Guide. This booklet was distributed to the readers of the Anglo Celt as part of Celtic Media Groups “Green Future” production which was published in October 2020. The booklet will also be distributed to householders at workshops, trade shows and information days held/attended by the Council in the future.

It will also be distributed to new Council Housing Tenants upon completion of their Pre-Tenancy Training and through the Green Schools Programme and Tidy Towns Network.

In 2020, the Waste Management Section created an 8 page booklet providing information on the Council’s recycling facilities throughout the County which will be used to generate greater environmental awareness and education. It will be distributed through our Green Schools and Tidy Towns Networks and to members of the public.

Enforcement Measures

In 2017, the Council acquired electronic handheld devices and developed a data capture app which has proved to be a more efficient method of logging and referral of complaints and enables Waste Enforcement staff to complete investigation reports onsite and upload photos and GPS coordinates of each site investigated remotely. This practice has reduced the amount of time spent by investigating officers in compiling reports and has reduced the amount of paperwork involved in each site.

In 2017, 2018 and 2019 the Council deployed covert CCTV surveillance at a number of known dumping blackspots and sites subject to abatement works across the County. In 2020, permanent CCTV was installed at 3 known dumping blackspots.

In 2018, the Council increased the use of smart technology with the addition of a drone to their enforcement toolkit. The drone has enabled Waste Enforcement staff a safe and efficient method of investigating difficult to access or large dump sites. Aerial imagery from the drone along with their handheld devices are used to record information as part of their investigations.

In 2019, drone ground school training was provided to all enforcement staff from the Waste Management and Environment Sections. This has given the staff the ability and relevant training to actively use the drone and comply with Irish Aviation Authority, Health & Safety and GDPR regulations.

National Tree Week

Planting more trees is the most efficient way of removing carbon from the atmosphere and combatting climate change. This annual campaign encourages people to plant more trees and get involved in local activities happening in their area. Each year during the Litter Management Plan 2016 – 2019, the Council received 200 native trees from the Tree Council of Ireland and provided these trees to Green Schools, Tidy Towns Groups and community groups. In 2020, 400 native trees were supplied free of charge to community groups.



Anti-Litter and Anti-Graffiti Grants (ALAG)

Grant funding is made available each year to Tidy Towns Groups who submit applications under the above scheme. All projects should seek to promote public awareness and education in relation to litter and/or graffiti and should have a particular focus on involving schools, youth groups, environmental groups, community and voluntary groups. Since 2016, the Council have grant aided Tidy Towns Groups a combined total of €76,806 to assist them in undertaking their annual projects.

Recycling Bring Centre Network and Civic Amenity Centres

There are 30 Recycling Bring Centre locations throughout the County where plastic bottles, glass jars and bottles, aluminium and tin cans and textiles can be recycled. The Council have undertaken upgrade and improvement works at a number of locations during the Litter Management Plan 2016 – 2019. Improvement works have included the relocation of Recycling Bring Centres to areas with improved access, installation of improved signage and an increase of recycling receptacles to increase recycling capacity.

Extensive improvement works were undertaken at Ballyjamesduff, Ballinagh and Kingscourt Bring Centres in 2020. Works included the clean up/removal of historical waste from underneath and behind recycling receptacles and the surrounding areas, the treatment of waste removed, containment of the sites by the installation of boundary walls/fences, the restoration of concrete plinths and protective barriers and the installation of poles accommodating new informational signage, cameras and lighting.

Objective 3 – Partnership with Communities and Businesses

During the lifetime of the Litter Management Plan 2016 – 2019, the Council worked in partnership with the Tidy Town Network, community and voluntary groups, resident associations and local businesses to provide a litter free environment for all.

Irish Business Against Litter (IBAL)

IBAL is an alliance of businesses who believe that litter has a significant impact on our economic wellbeing. An Taisce, on behalf of IBAL, assess litter levels in Ireland’s cities and larger towns against European Norms. Cavan Town has been participating since its inception in 2002.

The results show that Cavan Town has maintained its status as “Clean to European Norms” during the 2016 – 2019 period. At the end of 2015, Cavan Town secured a ranking of 12th place in the final survey of the year. However, the results for the 2016 – 2020 Anti-Litter Leagues has seen Cavan fluctuate up and down the league with Cavan Town placing in 23rd position out of 37 participating towns and cities at the end of 2020.

The IBAL surveys identified a number of locations where there was scope for improvement. Based on the findings of these Anti-Litter Leagues, the Council and Cavan Tidy Towns have directed resources towards addressing the problems of littering and illegal dumping in these areas.

Water Conservation and Eliminating use of Single Use Plastics

Creating a Businesses Network

The Waste Management Section selected 4 No. Tidy Town Groups to work with Refill Ireland to create a network of businesses across the County that would provide no obligation, free water refills to members of the public who have a reusable cup or bottle. These businesses were added to Refill Ireland's online Tap Map which highlights all businesses around the Country who are participating in this initiative. A social media campaign coordinated by Refill Ireland and the Council also supported this initiative. New business networks have been set up in the following towns and villages:



20 No. new businesses signed up in Cavan Town.

16 No. new businesses signed up in Virginia.

10 No. new businesses signed up in Cootehill.

5 No. new business signed up in Butlersbridge.

The new additions to the Tap Map are made up of a wide assortment of businesses with over twenty five different types of business participating including: hairdressers, pubs, restaurants, bike shops, pet stores, barbers, vaping stores, butchers, auctioneers, IT/Phone stores, pharmacies/chemists, hardware stores, clothes stores, college, cake shop, gift shop, bakeries, fast-food takeaway, jewellers, toy shops, deli's, butchers, health store, credit union, GAA club, newsagent, architects and flower shops.

Tidy Towns Network

The Council has developed a strong network of Tidy Towns Groups around the County. The number of Tidy Towns Groups has steadily increased from 13 in 2013 to 25 at the end of 2019. The work carried out by the Tidy Town Network has enhanced their local area and community involvement coordinated by these Tidy Towns Groups includes the support of resident associations, businesses and other community groups.

This community involvement is evident in the increase in groups participating in the National Spring Clean and National Tidy Towns Competition which has seen Tidy Towns Groups win awards in recognition for their endeavours.

Both the Tidy Towns Network and community and voluntary groups also provide invaluable information to the Council in relation to extent of litter in their areas. This information enables the Council to address incidences of littering and illegal dumping at a local level.

Belturbet Zero Waste (BZW)

BZW began as a local response to the global problem of unsustainable production and consumption. BZW is a community led intervention which encourages behavioural changes by identifying sustainable practices and policies aimed at reducing the carbon footprint of the Belturbet Community.



This 5-year waste prevention, awareness and communication project was launched in February 2019 and is led by Belturbet Tidy Towns in collaboration with the Council, the Connacht Ulster WERLA and the EPA. It has already won the 2019 Spark Change Award in the Communicator Category and the Best Waste Management Programme Award sponsored by REPAK at the All Ireland Community and Council Awards 2020.



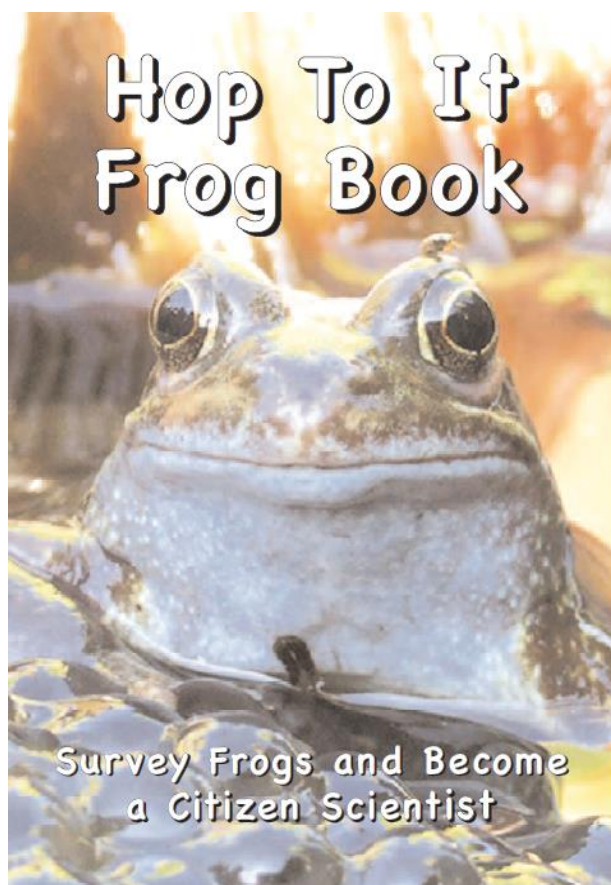

Community Environment Action Fund (formerly Local Agenda 21)

This scheme is jointly funded by the Department of Communications, Climate Action and Environment and Local Authorities to support projects that complement National Environmental Policies such as those on Waste, Biodiversity, Climate Change, Air, Water, Sustainable Development, etc. A wide variety of projects and schemes have been supported during the 2016 – 2019 period, for example, rainwater conservation schemes, biodiversity gardens, educational initiatives including workshops for primary and post primary schools and publishing of informational booklets.

Challenges facing the planning and implementation of Cavan County Council's Litter Management Plan 2021 – 2024

Impact of COVID-19 Restrictions

In January 2020, a new virus outbreak emerged known then as 2019-nCoV. The World Health Organisation (WHO) declared this outbreak as a public health emergency of International concern.

In February 2020, the WHO renamed the virus COVID-19 (coronavirus). On the 29th February 2020, the first known case of the virus was confirmed in Ireland. By the end of March 2020, the virus had taken a foothold in so many countries and due to the spread and severity of the virus the WHO recharacterised it as a pandemic.

The pandemic's arrival in Ireland saw the Government introduce new restrictions to reduce the spread, which affected many aspects of society including the cancellation of St. Patrick's Day parades and festivals, the closures of all schools, colleges, childcare and other public facilities.

COVID-19 will leave an enormous impact on how we consume, how we learn, work, socialise and how we communicate in the future. This crisis has affected every sector in this country and across the world and the road ahead is uncertain.

The Council are committed to supporting the community to navigate the COVID-19 situation. The Council will strive to ensure we maintain the same level of service to the community and we will do everything we can to offer assistance to isolated and/or vulnerable members of the community in County Cavan during the COVID-19 emergency.

However, the outbreak of COVID-19 has had a severe impact on development and implementation of the Litter Management Plan 2021 – 2024 including the following objectives:

Education Measures

- All Green Schools Visits planned after 12th March 2020 cancelled.
- Green Schools Awards ceremony cancelled.
- Tidy Schools Competition planned for Summer 2020 cancelled.
- Gum Litter Taskforce 2020 planned for June 2020 cancelled.
- All Green Schools Visits for 2021 were carried out virtually.

Awareness Measures

- National Spring Clean (NSC) planned for April 2020 suspended until July 2020.
- NSC clean ups scaled down to maximum of 15 participants with social distancing restrictions in place.
- Litter Leagues Surveys planned for 2020 and 2021 cancelled.
- National Litter Pollution & Quantification Surveys suspended until October – December 2020.

- Update of Litter & Waste Activities for 2019 to Elected Members deferred until October 2020.

Enforcement Measures

- Litter & Waste Complaint Investigations & Enforcement curtailed during March – June 2020.
- Increased patrols and maintenance of Recycling Bring Centres required during that period.

Prevention Measures

- Bank ATM Litter Surveys planned for May 2020 cancelled.
- Free Electrical & Electronic Recycling Bring Day organised by the European Recycling Platform cancelled.
- Anti-Litter and Anti-Graffiti Grants for 2020 deferred to 2021.

Partnership with Communities and Businesses

- Increased maintenance of the Recycling Bring Centre Network.
- Essential services provided by the three Civic Amenity Centres maintained in compliance with HSE Guidelines.
- Direct interaction with local voluntary groups including Tidy Towns Groups reduced.
- CEAF funding applications for 2020 deferred until further notice.

Climate and Biodiversity Action

- Tidy Towns Networking Seminar scheduled for April 2020 cancelled.

Objective 2: Enforcement

Enforcement activities will be a key focus for the Litter Management Plan 2021 – 2024. The Council have a statutory responsibility to enforce the Litter Pollution Act 1997 as amended, the Waste Management Act 1996 as amended, Bye-Laws and other relevant legislation.

Enforcement actions will be taken against those caught littering or dumping in the following ways:

- Issue On-the-Spot Litter Fines of €150 where evidence is available to identify the person(s) responsible for littering.
- Provide greater information to offenders and awareness to offenders to ensure repeat offences are not committed.
- Where Litter Fines have not been paid, initiate legal proceedings, attend Cavan District Court and bear witness against offenders which can result in fines of up to €4,000 and expenses incurred by the Council being imposed on polluters.
- More serious cases will go directly to court under the Waste Management Act 1996 as amended which can result in fines of up to €5,000 and expenses incurred by the Council being imposed on polluters.

The Council considers that education should not solely rest with the school population. There is also a need to engage with and educate the general public and the business/commercial sector through awareness campaigns to minimise the amount of waste they generate and become more resource efficient, which will reduce the levels of waste entering landfill and indiscriminate littering and dumping in the County.

The Council will promote the “Waste Management Hierarchy” which advocates prevention, re-use and recycling (including composting) over recovery and disposal.

Donating, refurbishing and repairing items such as bicycles offer people a chance to save money, get creative, learn a new skill and be environmentally conscious. Implementation, Monitoring and Evaluation

The Litter Management Plan 2021 – 2024 aims to improve on the standards of litter management and cleanliness attained in previous plans. It highlights the critical role to be played by the various sectors of the community in achieving this, and acknowledges their contribution

This Management Plan sets out the objectives and actions to be carried out over the lifetime of the Plan to eliminate litter, promote a cleaner environment, sustainable development and raise public awareness to environmental issues. An annual review of performance against the objectives and actions contained in this Litter Management Plan will be carried out. The Council will continue to contribute to the National Litter Pollution Monitoring System, and our activities will be informed by the results of these and other surveys.

A report in accordance with Section 10(3) of the Litter Pollution Act 1997 as amended, will be provided to the Council on an annual basis, setting out the outcomes achieved by the Waste Management Section in the previous calendar year against the objectives set out in the Litter Management Plan.

Summary

This Litter Management Plan will build on the existing partnerships forged with the community to combat all forms of litter and waste. All sectors of the community must work together to develop and maintain a clean, healthy living environment for all to enjoy.

Appendix 7 County of Cavan (Segregation, Storage and Presentation of Household and Commercial Waste) Bye-Laws, 2019

FAQs

DO THESE BYE-LAWS APPLY TO ME?

Yes: these bye-laws will apply to all households, apartments and commercial premises.

HOW DO I COMPLY WITH THE BYE-LAWS?

In order to manage your waste correctly you need to be able to prove that:

You have a contract in place with an authorised waste collector (bin sharing is permitted for which proof of agreement is required)

OR

You can demonstrate regular use of an authorised waste facility.

WHY DO WE NEED THESE BYE-LAWS?

To help you manage your waste in an environmentally acceptable manner.

To ensure that your waste is only given to an authorised door-to door waste collector or brought to an authorised waste facility

To help ensure your waste is correctly segregated

To reduce illegal dumping and backyard burning.

WHAT HAPPENS IF I DON'T COMPLY?

If you fail to comply with any of the requirements of the Bye-Laws, it may result in a Fixed Penalty Notice (Maximum €75) being issued by this Council or a member of An Garda Síochána. It may also lead to a fine on conviction of up to €2,500.

WHAT DO I DO IF I LIVE IN A MANAGED APARTMENT COMPLEX?

The bye-laws will still apply; the management company is to ensure adequate containers are provided for residual and recyclable wastes in designated waste storage points. They are also obliged to provide you with the written information regarding the arrangements in place. Segregation within the apartments will be the responsibility of the occupant, in order for the segregated system to work all apartments must play their part.

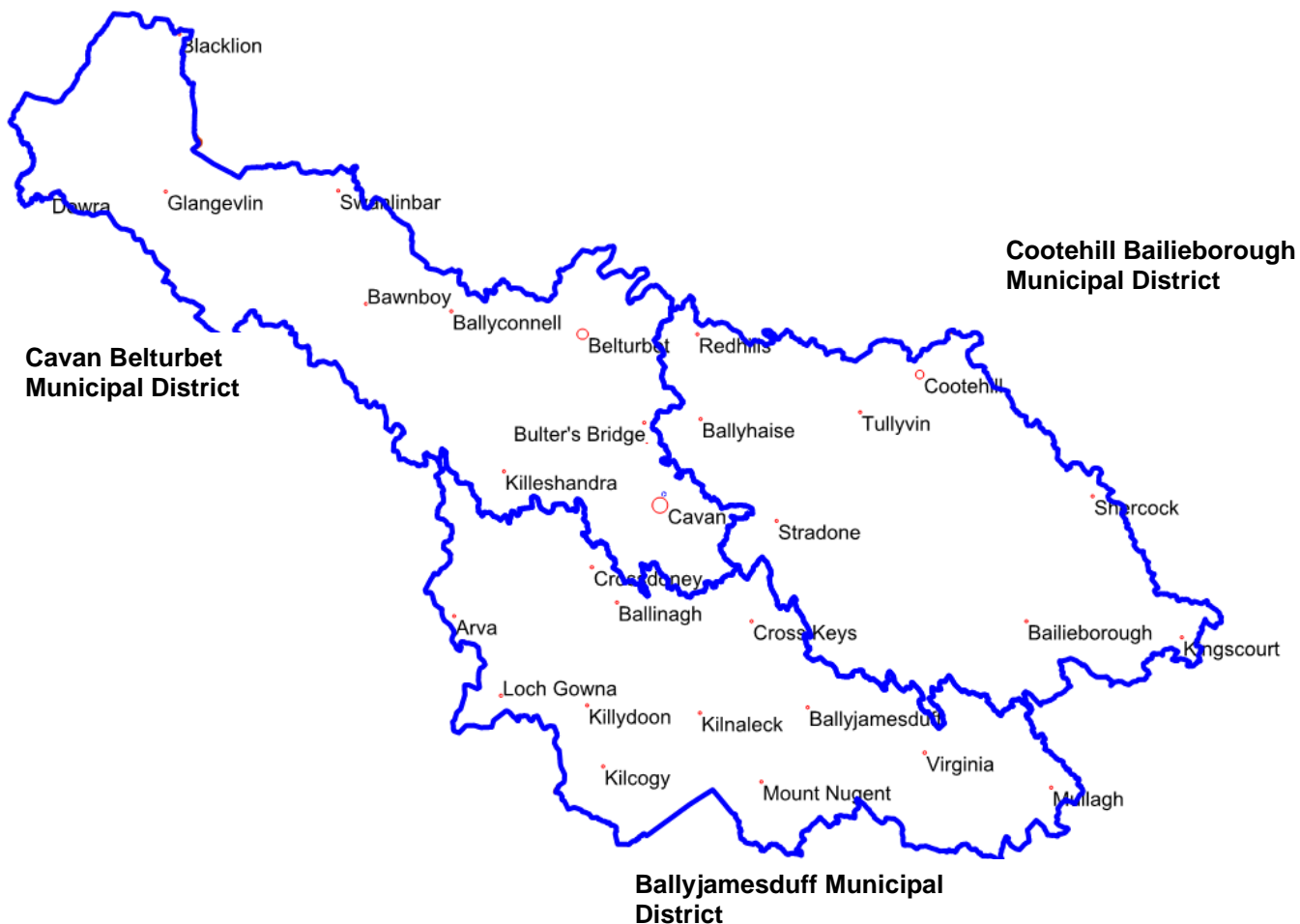
IS THERE ANYTHING ELSE I NEED TO DO?

Yes, you must segregate recyclable waste from your residual waste and present these separately. If you are living in an urban area, small town or village with a population of over 500 you must also segregate your food waste.

Appendix 10 General Data Protection Regulations (GDPR)

CCTV surveillance systems are a key component in preventing, detecting or investigating offences and apprehending offenders and securing subsequent prosecutions. While it is recognised that the systematic use of CCTV surveillance can undermine citizens privacy needs, processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority under Litter Pollution Act 1997 as amended, Waste Management Act 1996 as amended and Part 5 of the Data Protection Act 2018. CCTV surveillance systems capture data i.e. images of persons, vehicle registrations, etc. which is their personal data. This confers rights on them under Data Protection Legislation. The Council have a duty and obligation as the holder of this personal data to ensure such data is stored, handled, processed and destroyed correctly.



The collection and processing of video footage and any data generated from this activity will be strictly controlled under the provisions of the Data Protection Act 2018 (including Part 5 of the Data Protection Act 2018 which implements the Law Enforcement Directive (EU) 2016/80 into Irish law) and also under the requirements of GDPR. The Council will seek to comply with best practice suggestions and guidance from the Data Protection Commission.

The Council undertakes to operate its CCTV surveillance system, and undertakes to ensure that those who operate it on the Council's behalf do so within the terms of this policy and the law and will review it regularly to ensure continuing compliance with the relevant legislation.

The Council's CCTV Data Protection Policy addresses these issues and sets out clearly what the Council, as Data Controller, must do to protect personal data in relation to our CCTV surveillance systems. Before implementing CCTV surveillance systems at new locations or before implementing changes to existing our CCTV surveillance systems, it may be necessary to conduct a Data Protection Impact Assessment ("DPIA"). DPIAs are carried where proposed data processing "is likely to result in a high risk to the rights and freedoms of natural persons."

To reduce the risk of recording personal data, the Council will be upgrading the signage at each Recycling Bring Centre to notify the public that CCTV surveillance is in place and to inform them of their rights under GDPR.
