CMTCU wish to invite tenders from interested parties in *Digitally Mapping* all of its passenger transport services across Cavan and Monaghan.

Key Outputs

- Produce an interactive digital area map of Cavan and Monaghan displaying all CMTCU transport services
- Preparation of transport service requirement profile of each service
- Identification of potential service risks
- Analysis of potential service integration
- Digitisation of all services by hour/day/week
